MONITORING & REVIEW Intervention Summary

Hayley & Vicki presented Year 2 Literacy Intervention Summary Report to board.

- 18 students were identified as priority learners.
- Students worked with the teacher, teacher aide and intervention teacher.
- Students all made some form of progress in reading and all except 1 made progress in their writing level.
- Related writing to relevant everyday experiences.
- Oral language was a need with some of the students and improvements were made not only in their writing but also in oral language and communicating with others.
- Will continue writing programme in Term 4 along with hands on experience.
 Shaun thanked Hayley and Vicki for their report and for the work put into the intervention programme.

Mid Year Data Report

Steve presented report on Mid Year Data for Reading, Writing and Maths.

- Reading overall 82% of students are working within or above the expected level. Also, an increase in Maori students working within or above from 66% last year to 79% this year.
- Writing 74% working within or above expected level. Maori figures are the same as last year with 66% working within or above.
- Maths no change in these figures. 78% school wide working within or above with 65% Maori achieving the same levels.

2019 Targets are for identified Year 2 priority learners to make progress in Reading & Writing and Maori students not meeting curriculum expectations to make accelerated progress in Literacy & Numeracy.
